

## Terms and Conditions for Devices Payment Plan and Systems Payment Plan:

This piece of the Standard Terms sets out the terms and situation which apply in regard of the System Payment Plan, also called "SPP" and the Devices Payment Plan, also called "DPP".

The terms and conditions in Sections 1 and 2 and, if material, additionally apply Section 3.
